- SECTIONS OF 4**

15 ends per game

1st round 1 v 2 and 3 v 4
 2nd round 1 v 3 and 2 v 4
 3rd round 1 v 4 and 2 v 3
- SECTIONS OF 3**

1st Round - Team 1 vs Team 2 and Team 3 has the BYE
 2nd Round - Winner of Team 1 and 2 has a BYE for the 2nd Round, and the loser plays against Team 3
 3rd round - 1 - Winner of 1 and 2 plays Team 3
- ALL GAMES MUST BE PLAYED**
- DRAW FOR RINKS - First round draw for rinks thereafter rinks must be allocated. No one to play on same rink twice. Third round play in different direction and rinks can be drawn again.**
- Tea after conclusion of 1st game and lunch after conclusion of 2nd game
- Playoffs as per attached chart. 21 ends will be played in the playoffs.
